



2021-22 COMMUNITY COMPACT AGREEMENT

To protect our community during the COVID-19 pandemic, Woodstock Day School (WDS) has implemented health and safety protocols with the goals of providing full-time, in-person learning throughout the school year and minimizing potential disruptions to classroom time and student learning. With these important goals in mind, WDS has developed COVID protocols that go above and beyond and that require collaboration with the entire WDS community.

Preventing transmission of COVID-19 and its variants hinges on responsible behavior of every WDS community member at all times to uphold our health and safety protocols. We want to ensure that our school can remain open as a safe space for our students to grow and learn. As a valued member of the WDS community, we need you to affirm that you understand the guidelines and expectations detailed below and will fully comply with them. While we strongly encourage that eligible people are vaccinated, we are not mandating it at this time. If you cannot meet the terms of this Community Compact Agreement, please contact the COVID Team to discuss these challenges and what this will mean for our students.

Part One

AS A FACULTY, STAFF, PARENT, OR STUDENT MEMBER OF OUR SCHOOL COMMUNITY, I AFFIRM THAT I WILL:

1. MONITOR MY HEALTH DAILY AND HONESTLY REPORT SYMPTOMS to the administration if I or anyone in my household is experiencing any of the following symptoms of COVID-19 and its variants: fever of 100.4 or higher, chills, shortness of breath, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, and/or diarrhea.
2. ISOLATE AND SELF-QUARANTINE as directed or instructed by the School before returning to school or after exposure to someone who is ill with an infectious disease or has tested positive for COVID-19.
3. MAINTAIN PHYSICAL DISTANCING WHEN APPROPRIATE AND AS DIRECTED BY WDS ADMINISTRATORS AND STAFF in all settings, both on- and off-campus.
4. PROPERLY WEAR AN APPROPRIATE FACE COVERING, regardless of vaccination status, over my mouth and nose when indoors, in public spaces, and in any other setting where it is difficult to maintain physical distancing, both on- and off-campus.

5. WASH MY HANDS FREQUENTLY with soap and water (or hand sanitizer if soap and water are not available), and contribute to the cleaning of surfaces as requested.
6. CAREFULLY OBSERVE AND FOLLOW campus and building instructional signs and directions as well as school staff instructions and appropriate interactions only within one's group when directed.
7. PARTICIPATE IN REQUIRED AND RECOMMENDED COVID-19 TESTING AND CONTACT TRACING, regardless of vaccination status, to preserve the wellness of the WDS community.
8. BE POSITIVE AND GRACIOUS when others provide safety reminders and suggestions.
9. BE ATTENTIVE AND HELPFUL to anyone around who may be in need of support.
10. BE UNDERSTANDING that the rules are implemented for a reason, and will treat others as I would want to be treated in the event that someone within the community tests positive for COVID-19.

AS A FACULTY, STAFF, PARENT, OR STUDENT MEMBER OF OUR SCHOOL COMMUNITY, I WILL:

1. COMMUNICATE ALL KNOWN CONFIRMED OR POTENTIAL EXPOSURES OF COVID-19 to the WDS administrative team by emailing covidteam@woodstockdayschool.org and filling out our [COVID-19 Exposure Form](#) within 24 hours.
2. AVOID UNNECESSARY TRAVEL and use of mass transportation, given the status of COVID-19 and its variants. If I or anyone in my household has traveled to a COVID-19 hot spot (please see the updated list at: <https://www.cdc.gov/coronavirus/2019-ncov/travelers/map-and-travel-notices.html>) I will notify the WDS COVID Team immediately so they are aware of the potential risk and to receive instructions regarding how long I may need to quarantine for and whether I must receive a negative COVID-19 test before I can return to campus.
3. FOLLOW CDC GUIDELINES even after receiving all necessary vaccine doses. For more information, please see the CDC guidelines [here](#).
